LOUISVILLE YOUTH CHOIR ANNUALLY DRAWS OVER 100 YOUTH FROM THROUGHOUT THE METROPOLITAN AREA, AND ITS MUSICAL REPERTOIRE INCLUDES MANY STYLES AND CULTURES, INCLUDING MAJOR CLASSICS AND MODERN WORKS, OFTEN PERFORMED WITH SOLOISTS AND ORCHESTRAS. OPEN AUDITIONS ARE HELD SEASONALLY THROUGHOUT THE YEAR, AND WEEKLY REHEARSALS CULMINATE IN MORE THAN FIVE PUBLIC PERFORMANCES ANNUALLY.
